

## **Guidance on the consumer's right to rescind the contract**

### **1. Right to rescind the contract**

**1.1** You have the right to rescind the contract for up to 14 days, without stating a reason.

**1.2** You have the right to rescind the contract, without stating a reason, for up to 14 days from the day following the day on which you, or your assigned third party (other than a carrier), accept the goods.

**1.3** To exercise the right to rescind the contract, you must inform the following company of your withdrawal from this contract: **unitechnic.cz s.r.o., U Vysočanského pivovaru 701/3, 190 00 Prague. Telephone number +420 266 190 190, fax + 420 266 190 100, e-mail obchod@khnet.cz**, in the form of unilateral legal conduct (for example, a letter sent through the postal service, fax or e-mail). You may use the attached model rescindance form from the contract, but this is not your obligation.

**1.4** In order to respect the deadline for the rescinding of the contract, it is sufficient to send notification of rescindance from the contract before the relevant deadline.

### **2. Consequences of rescinding of the contract**

**2.1.** We return the payment only after receiving the returned goods or, if it is evidenced, that you have sent the goods back, whichever comes first.

**2.2** Send back, or hand over, the goods without undue delay, within 14 days from the date of rescinding this contract, to this address: **unitechnic.cz s.r.o., Hlavní 29, 277 45 Úžice, contact person: Renata Schejbalová**. The deadline shall be sustained, if you send us back the goods before the expiration of 14 days.

You bear the direct cost of returning the goods.

**2.3.** Only you are liable for any diminished value of the goods resulting from the handling in any other way than that which is necessary to establish the nature and characteristics of goods, including functionality.
